Not to collect the Exam fee from Blind, Physically Disabled, Deaf & Dumb students as per S.U Order No.497/SU/KNR/RP/2010-11, dated 7-12-2010. A Xerox Copy of Medical Certificate confirming their status as Handicapped(minimum percentage of disability must be of 40%) must be attached to the Application forms. Blind, Physically Disabled, Deaf & Dumb Students Application forms should be submitted separately along with Separate Nominal Roll.

The candidates appearing for B.Ed. III Semester Examinations are advised to enclose the xerox copies of B.Ed. I & II Semester Memo of Marks.
