

1. Candidates should fill the examination application form and get verified by the HOD/BOS concerned department and submit to the Principal concerned.
2. The HOD/BOS of the concerned faculties are requested to verify the Examination Application forms.
3. The candidates who are appearing for Pre-Ph.D. examinations should write the Paper I and II titles in the application form compulsory. Incomplete application forms will not be accepted.
4. Candidates are also instructed to enclose along with application form, a **photo copy of PG degree certificate and Ph.D Order Copy** duly attested and Migration certificate in original with a fee of Rs. 250/- (for the candidates other than Satavahana University).
