Applications (in quadruplicate) are invited from the eligible teachers in the prescribed proforma for promotion/award of higher Academic Grade Pay (AGP) under Career Advancement Scheme as per the eligibility criteria as outlined and prescribed in the GO and the UGC Regulations referred to above ( under the Reference ). The teachers who become eligible as on 31/12/2018 or before and fulfil other requirements as per the rules in force shall only apply in response to this Circular. The applications duly filled in along with all supporting documents should be submitted through proper channel in the Office of the undersigned on or before 31/12/2018. Applications of ineligible teachers and those submitted later than 31/12/2018 shall summarily be rejected. Applications received without proper and supporting documents shall not be scrutinised. Applications received from the teachers shall be considered as per the rules in force and subject to the fulfilment of eligibility criteria as per the GO and UGC Regulations referred to above. The teachers are informed to refer to the GO and the UGC Regulations referred to above for comprehensive information and for more details on CAS promotions/award of higher AGP. The teachers are requested to exercise their option for being considered under the existing Regulations/GO or UGC Regulations 2018 as the case may be while submitting their application forms. The prescribed application forms can be collected from the office of the undersigned on or after 21/12/2018.

The Principals of the constituent colleges are requested to circulate this among the teachers and forward their application forms on or before the stipulated date for receipt of filled in application forms.
